

# Solar Hot Water Retrofit Rebate - Application Form

Complete and sign the following application form and lodge it with Power and Water once installation of an eligible solar hot water system has occurred. Please note:

- This application form should be submitted within six months of installation.
- Applications must be lodged before 30 June 2010.
- Applications will only be accepted after the solar hot water system has been installed, meets eligibility requirements and is certified by a licensed installer.
- The rebate is not available as a point of sale discount. Only the home owner or tenant with their approval can claim the rebate.
- Applications may take up to eight weeks to be processed.

- Applicants must submit a copy of their purchase receipt, itemised receipt for work completed on their roof plus a certificate of compliance for all modifications with their applications.
- The Solar Hot Water Retrofit Rebate requires the applicant to agree and provide evidence to support claims made in the application to ensure the applicant has met all program guidelines, if requested at a later date for audit purposes.
- Power and Water reserves the right to conduct inspections.
- If you are assigning your Renewable Energy Certificates (RECs) to Power and Water your installation report (warranty/guarantee certificate) should be completed by your plumber/installer and must be attached to this application.

Submitting an application does not automatically qualify you for a rebate. Power and Water and the Northern Territory Government reserves the right to request further information or decline an application. Applicants must satisfy all eligibility requirements found on the website [powerwater.com.au](http://powerwater.com.au) before payment of the rebate is made.

Completed applications must include:

- a copy of the receipt for the purchase of the new solar hot water system,
- this form countersigned by the installer,
- a certificate of compliance, and
- BSB and bank account details for the electronic payment of the rebate.

If assigning your RECs to Power and Water:

- your application must also include your installation certificate,
- your solar hot water system must be certified against Australian Standard AS2712:2007, and
- you must not create any further RECs in relation to that solar hot water system (it is an offence under the *Renewable Energy (Electricity) Act 2000 (Cth)*).
