

Terms and conditions

Quality standard

To be eligible for this scheme all solar photovoltaic systems are required to be certified against Australian Standard AS4777:2007 for design, manufacture and installation.

Assignment

Upon assignment of your right to create RECs to Power and Water, you are not entitled to create any further RECs in relation to that solar photovoltaic system. The improper creation of RECs is an offence under the *Renewable Energy (Electricity) Act 2000 (Cth)*.

RECs must be applied for and assigned within 12 months of the installation date. To allow the RECs to be assigned within the 12 month time limit, the owner is responsible for ensuring that all information required is presented to Power and Water one month prior to the expiry date. RECs not assigned within the 12 month time limit become null and void and cannot be claimed.

It is an offence to make a false or misleading claim. Power and Water will retain this statement for five years.

Price of RECs

The price of RECs offered by Power and Water may fluctuate. Power and Water accepts no responsibility for loss arising from variances in the market price offered for RECs. To obtain the current RECs price contact Power and Water on 1800 245 092.
