### Completing the Approval Application Form

Fields marked with an asterisk (\*) are mandatory and must be completed.

Where there has been a **WSAA appraisal** and it is still current, only Applicant and Northern Territory Distributor details in the form need be completed, unless otherwise requested. Where the WSAA appraisal does not cover product ordering codes, these **must** be provided for all sizes, classes and other variations of the product.

Otherwise fully complete this form and append all appropriate certificates and test reports as required for verification and any other product information that may assist in understanding the product. Incomplete forms may be returned for completion without processing.

Complete separate application forms for:

- a) Products made to different standards/specifications, e.g. DI pipes, GRP pipes, air valves, swing check valves etc.
- b) Products from different manufacturers.
