

Procurement Outlook - FY 26 through to FY 28 (Updated October 2025)

Each year Power and Water publishes on its website its Procurement Outlook; a projection of contracting opportunities over the next 12 to 36 months. By publishing this Outlook, Power and Water provides industry with advance notice of likely procurement activity over the forecast period for all goods, works and services.

The Procurement Outlook includes projections of all anticipated tender opportunities above \$200,000 over the period. Procurement activities forecast for the next twelve months are more likely to eventuate than those in the outer years.

The Outlook is a dynamic document and is updated in April and October, as new opportunities emerge and as some of the more 'blue sky' actions become firmer. Industry is encouraged to review the Outlook periodically to keep abreast of these changes and emerging opportunities.

Opportunities for Local Business

The Northern Territory is a large place with a relatively small population and shallow industrial base. Many local businesses often may lack the scale required to compete for large projects or projects in remote regions that require sustained logistical support. These are all challenges we face in building local industry participation.

Splitting up large projects into smaller modules providing appropriate opportunities for local business to compete through effective contract structure and market approaches is one way that Power and Water helps local business overcome the problems of scale and remoteness. Over time, this strategy helps Territory businesses grow to a size where they can compete on an equal footing on a national and international scale. Where commercial objectives are optimised by bundling areas of supply, Power and Water provides maximum advance notice to enable local businesses to form partnerships, subcontracting or other arrangements to tender for these consolidated opportunities.

Power and Water is committed to increasing prime contract awards and subcontract awards to the Northern Territory small business community. We hope that the Outlook will assist you in doing business with Power and Water. By helping businesses identify procurement opportunities as early in the acquisition process as possible, we hope to improve communication with industry and assist the small business community with its marketing and tendering efforts.
