Sitepass is a safety system utilised for Power and Water Corporation to demonstrate that we have discharged our duty of care and we have also demonstrated that we have made contractors aware of the potential risks and our requirements associated with working on or within Power and Water assets and infrastructure.

Power and Water has developed a range of training courses for different requirements with the majority of these courses online. In passing these courses via a test the contractor has demonstrated their understanding of the risks associated with work they will be undertaking and Power and Water have discharged our Federal Government legislative requirements. Power and Water provides the initial face to face training in Darwin and Alice Springs free of charge. The online courses are also free of charge.

The system records and keeps track of requirements for persons working on or in the vicinity of Power and Water assets and infrastructure. Power and Water has a duty of care to people who perform work on our assets or working within the vicinity of Power and Water assets that have high risk of injury.
